Dominion VA Power Demand Rebilling & Refund Plans

For several years, we identified suspected errors in the demand charges for some customers of Dominion VA Power. In some cases, the demand reading on the meter had gotten stuck at the same level for multiple months. We have secured significant refunds for some customers as a result of identifying these errors.

In April 2016, Dominion acknowledged that there had been demand billing errors for many small and mid-size commercial customers. They identified approximately 24,000 commercial customers who were impacted by the problems. These customers had an identical KW demand reading at least two months in a row between July 2013 and June 2016. This was because the demand reading was not reset to zero in some months. The errors impacted 10% of commercial customers in the 30 KW to 500 KW demand range.

Dominion submitted a proposal to the VA Public Service Commission for approval of the "Demand Rebilling and Refund Plan." The plan was approved, and the 24,000 identified customers were sent letters explaining the

Customers who did not get a credit on their bills but have the potential for this same type of error were sent a letter notifying them of the potential problem.

East Coast Nuclear Plants



Since our last newsletter, the U.S. Department of Energy increased their total loan guarantees on the GA Power Vogtle Plant to \$12 billion. Since the Westinghouse bankruptcy, GA Power has contracted with Becthel to finish construction of units 3 and 4. The original cost projections for the units totaled \$14 billion; the updated projection is \$25 billion and climbing. The units were originally projected to go on line in 2016 and 2017, but new estimates call for 2022 or later.

At UMS, we project that at least one of these units will never produce power. Customers and stockholders of The Southern Company will likely share the losses, and it's possible that U.S. taxpayer dollars will contribute.



SCE&G, subsidiary of SCANA, and Santee-Cooper, a state-run power company, spent \$11 billion on 2 new units at the V.C. Summer Plant. That includes \$2 billion that was paid by customers through higher rates and \$9 billion that SCE&G and Santee Cooper are now trying to pass along to their customers. After the Westinghouse bankruptcy, construction on both units was canceled.

On the day the SCANA Chief Executive Officer was quoted in the newspaper saying he would not be leaving or retiring, it was

Former President George W. Bush spoke at the World Energy Engineering Congress in Atlanta, Georgia on October 27th.


