Loan Guarantee

The U.S. Department of Energy has increased their total loan guarantees to back construction of Units 3 and 4 at the Vogtle Plant to \$12 billion. This shifts some of the risk for this project from utility customers in Georgia to the American taxpayer. It appears that the loan guarantees only take effect if the owners of the plant default on their debt obligations.

Impact on Electric Rates

The total construction cost for the new units is now expected to exceed \$25 billion. Significant rate increases are expected for customers of Georgia Power, MEAG, Oglethorpe Power Corporation and Dalton Utilities - the owners of the ill-fated nuclear units. These increases will likely lead to higher rates for several decades.

Will you be better off on a different electric rate?

Possibly.

Since the bankruptcy of Westinghouse, the firm that was building the new nuclear generating units at the Vogtle Plant, Georgia Power has entered into a contract with Bechtel to manage the construction work required to finish building the units.

Will the plants ever produce electricity?

No one knows for sure.

At UMS, we believe that unit 4 will never be completed while unit 3 may be completed. We make that prediction based on the extensive history of canceled plants in the nuclear industry. See below for an example.

VC Summer Plant Update

Things could be worse in Georgia. Two nuclear generating units at the VC Summer Plant were being constructed by Westinghouse for South Carolina Electric & Gas and Santee Cooper. Since the Westinghouse bankruptcy, plans have been canceled for those plants. Almost \$10 billion was invested in the failed projects for units that are less than half completed.

SCE&G customers have already paid \$1.7 billion toward the project through electric rates. SCE&G has requested the SC Public Service Commission to include their remaining losses in future electric rates. If approved, we estimate the average residential, commercial and industrial customer will pay the following amounts over several decades for units that will never produce power:

Residential Commercial Industrial \$3,000 \$20,000 \$1,800,000

The Summer Plant did not have federal loan guarantees. A legal, political and lobbying fight is underway to determine who will pay for the plant. South Carolina has opened criminal investigations into SCE&G. According to news outlets, indictments of SCE&G executives are likely. Multiple shareholder class action lawsuits have been filed alleging SCE&G executives intentionally misled shareholders about the cost, schedule and status of the project. Bankruptcy is possible.

Former President George W. Bush spoke at the World Energy Engineering Congress in Atlanta, Georgia on October 27th.


